

DEED OF CAPITAL CONTRIBUTION

This Deed of Capital Contribution (the "Deed") is entered into as of 17th of June 2025 by and between:

1. **LOTOSTORM B.V.**, a company incorporated under the laws of Curaçao, with its registration number: 163910 and its registered office at: 03, Abraham Mendez Chumaceiro Boulevard, Willemstad, 4750, Curacao ("LOTOSTORM");
2. **WOOLFEATWOLF LIMITED**, a company incorporated under the laws of Cyprus, with its registration number: HE 448601 and its registered office at: 11, Filippou, Agios Dometios, Nicosia, 2363, Cyprus ("WOOLFEATWOLF"),

(collectively – the "COMPANIES"); and
3. **Mr. Volodymyr Zhukovskiy**, citizen of Ukraine, born on 28th of May 1981, with his passport number FE104208 and registered address at: 62, Devladovo Street Pershotravneva, Apt.: 5, Kryvyi Rih District, Dnipropetrovsk, Ukraine (the "UBO"),

(collectively – the "Parties").

RECITALS:

WHEREAS, the UBO is the sole shareholder of LOTOSTORM, and the LOTOSTORM is the sole shareholder of WOOLFEATWOLF;

WHEREAS, the UBO is the Ultimate Beneficial Owner of the Companies;

WHEREAS, the UBO and LOTOSTORM wish to contribute funds to WOOLFEATWOLF for the development of its business and to increase WOOLFEATWOLF's reserves;

WHEREAS, the UBO and LOTOSTORM agree to treat this transaction as a capital contribution from the UBO to LOTOSTORM, creating an equivalent contribution from LOTOSTORM to WOOLFEATWOLF and an obligation on the part of LOTOSTORM to the UBO;

WHEREAS, LOTOSTORM and WOOLFEATWOLF agree to treat this transaction as a capital contribution from LOTOSTORM to WOOLFEATWOLF;

NOW, THEREFORE, the Parties agree as follows:

1. CONTRIBUTION OF FUNDS

1.1. The UBO shall contribute to WOOLFEATWOLF EUR 20,000.00 (the "Contribution") which can be transferred in parts and shall be used for development of the business of WOOLFEATWOLF and increase of the reserves of WOOLFEATWOLF.

1.2. UBO and LOTOSTORM agree to treat and reflect this transaction as a capital contribution from the UBO to LOTOSTORM, establishing an obligation from LOTOSTORM to the UBO.

1.3. LOTOSTORM and WOOLFEATWOLF further agree to treat and reflect this transaction as part of LOTOSTORM's capital contribution to WOOLFEATWOLF in its capacity as WOOLFEATWOLF's sole shareholder.

1.4. WOOLFEATWOLF confirms that the Contribution shall be used for the development of its business and to increase its reserves, which can be done in the various forms.

2. ACKNOWLEDGMENT OF TRANSACTION

2.1. All Parties agree that the funds transferred by the UBO to WOOLFEATWOLF shall be deemed a capital contribution by LOTOSTORM in its capacity as the shareholder of WOOLFEATWOLF.

2.2. LOTOSTORM acknowledges that the source of these funds is the UBO and shall document this accordingly in its internal records.

2.3. WOOLFEATWOLF acknowledges that the Contribution has been made on behalf of its shareholder, LOTOSTORM, and shall document this accordingly in its internal records.
