ADDITION OF BRANDED GAME "JURASSIC PARK" TO YOUR CURRENT SOFTWARE LICENCE WITH QUICKFIRE LIMITED ("QUICKFIRE")

We refer to your licence agreement with Quickfire (the "**Software Licence**").

The JURASSIC PARK brand and all associated intellectual property rights (collectively, the "**Jurassic Park IP**") has been licensed to Apricot Investments Limited ("**Microgaming**"). Microgaming has developed an online slot game based on the JURASSIC PARK IP (the "**Jurassic Park Game**"). The term "Jurassic Park Game" includes all games developed by Microgaming based on the Jurassic Park IP as well as all updated or revised versions of such games.

Microgaming has licensed the use of the Jurassic Park Game to Quickfire and Quickfire is authorised to make the Jurassic Park Game available to you for licensed use. This letter agreement (this "**Jurassic Park Licence**") serves to confirm that all the terms and conditions of the Software Licence, as well as the terms set out in this Jurassic Park Licence shall apply to your use of the Jurassic Park Game. The Jurassic Park Game is a "Branded Game" as defined in the Software Licence. To the extent the Software Licence is contradicted by this Jurassic Park Licence, this Jurassic Park Licence will apply.

Under no circumstances may you use the Jurassic Park Game or the Jurassic Park IP in any manner whatsoever other than in the form of the Jurassic Park Game as provided to you in terms of the Software Licence and this Jurassic Park Licence. You agree that you will use the Jurassic Park IP only in the manner agreed or as prescribed in writing by Quickfire in its sole discretion from time to time, and with acknowledgement where appropriate or where required by Quickfire.

You and your Internet affiliates (if applicable) shall require Quickfire's prior written consent and sign-off prior to the launch of any and all marketing, promotional campaigns, advertising, press releases and any other materials which are proposed to be used by you or your Internet affiliates which relate to the Jurassic Park Game or in any way incorporates the Jurassic Park IP, or any part thereof ("**Advertising Materials**").

You agree that no injurious, deleterious or defamatory material, writing or images shall be used in or on your Advertising Materials and these shall be developed and distributed as follows: (A) without the use of child labour (the term "child" refers to a person younger than the age for completing compulsory education, but in no case shall a child younger than 14(fourteen) years of age be so used); (B) in an environment providing workers and employees with a safe and healthy workplace in compliance with

all applicable laws; (C) employing only persons whose employment is voluntary and not using prison labour or corporal punishment (or other forms of mental or physical coercion) as a form of discipline for workers or employees; (D) complying with all applicable wage and hour laws, including minimum wage, overtime and maximum hours, and utilising such other fair employment practices as defined by applicable laws; (E) not discriminating in hiring and employment practices on the grounds of race, religion, national origin, political affiliation, sexual orientation, gender or any criteria protected by applicable law; and (F) complying with all applicable environmental and animal cruelty laws.

You acknowledge that the Jurassic Park Game and Jurassic Park IP, and all goodwill associated therewith, including any updates, upgrades and all additions, corrections, modifications and improvements thereto and derivative works thereof, will at all times remain the property of the Jurassic Park IP's rights holders. No other licence in relation to the Jurassic Park IP shall be implied in your favour by virtue of the provisions of any term of this Jurassic Park Licence. You agree that you shall not attack the title to or any rights to the Jurassic Park Game or the Jurassic Park IP.

You agree that you will not claim any rights, title or interest in the Jurassic Park Game and Jurassic Park IP, or any part thereof. You agree that you will not use or register, or authorise others to use or register, any copyrights, trade marks, designs, patents, film footage, music or other form of intellectual property rights which is related to or incorporates the Jurassic Park IP (or part thereof) at any time or, for any purpose whatsoever. For clarity, you and your Internet affiliates are not entitled to use, or authorise others to use, any domain name or any other trade name incorporating the Jurassic Park IP or any component or alternate spelling thereof or any similar or confusingly similar term thereto for any reason whatsoever (including in order to advertise, publicise, promote or distribute the Jurassic Park Game or to provide a means for your end users to obtain the Jurassic Park Game), without prior written consent.

Under no circumstances whatsoever may you use, distribute, advertise, promote or otherwise exploit the Jurassic Park Game or the Jurassic Park IP within the United States of America or within any jurisdiction where the exploitation of the Jurassic Park Game is expressly prohibited by law or similar governing order ("**Excluded Jurisdictions**"). You agree to employ adequate safeguards to establish the locality of your end users and ensure your end users located in any Excluded Jurisdictions cannot deposit monies for use with the Jurassic Park Game. If you become aware that you have received monies from end users located in such territories you shall immediately return such monies. Quickfire reserves the right, on written notice to you, to block availability of the Jurassic Park Game to end users in any jurisdiction where PNL / PNS / QUICKFIRE believes that prohibited activities are taking place in respect of the Jurassic Park Game.

The Jurassic Park Game can be withdrawn by Quickfire from use by you at any time and without liability to you of any kind.

You are not entitled to further sublicense your rights to the Jurassic Park Game and Jurassic Park IP, but you have the right to sublicense your Internet affiliates to promote and advertise the Jurassic Park Game for the sole purpose of driving end users to your authorised websites. Any such Internet affiliates will be bound by, and will comply with, this Jurassic Park Licence.

Any acts by you contrary to the terms of this Jurassic Park Licence shall be deemed a material breach of the Software Licence. This Jurassic Park Licence will be governed by and construed in accordance with the laws of England and Wales.
