(jointly referred to as the "**Parties**" and separately as the "**Party**")

1. The Parties have concluded the Service Agreement on the 3rd of January 2022 ("**Agreement**").
2. The Parties wish to prolong the Curacao online gambling licence provided under the Agreement. Therefore, the Parties hereby agree on the changes stipulated in this Amendment no.3.
3. The Parties hereby agree to modify the wording of the current Annex 1 to the Agreement. The new Annex 1 to the Agreement shall have the following wording:

"Annex 1 Specification of Services and Remuneration

Service	Remuneration
<i>Arranging an online gambling license in Curacao on behalf of the Customer</i> - This includes initial application fee and local ISP service for compliance backups - Including two (2) websites	11,000 EUR - The remuneration shall be paid in within 10 days from the date of signing of the Agreement.



	- This Service was already provided to the Customer by the Provider before the effective date of the Amendment no.2.
Adding 3 rd and additional websites under the online gambling licence in Curacao on behalf of the Customer	800 EUR per website - The remuneration shall be paid in advance after a request.
Mirror website validation under the online gambling licence in Curacao on behalf of the Customer	120 EUR per website - The remuneration shall be paid in advance after a request.
Prolongation of the gambling licence issued by master licence holder in Curacao. - This includes application fee and local ISP service for compliance backups. - This includes Customer's 12 (twelve) licensed websites. - The online gambling licence will be valid from the date of the issuance until July 2024.	14,750 EUR - The remuneration shall be paid within 10 days from the date of signing of the Amendment no.3.
Assistance in matters not mentioned above	200 EUR per hour - An hourly fee for each hour spent by the Provider on providing of the Services not mentioned above to the Customer. - Payable within 10 days from the Customer's receipt of the Provider's invoice (which shall specify the services and hours spent on their provision). - NOTE: The Provider shall always specify the nature of these services and inform the Customer in advance about these and the Customer shall always confirm the provision of these specified services.

4. This Amendment no.3 shall become effective on the day of its signing by the Parties.
