The company

INVERSIONES FCW Ltd, formerly **INVERSIONES FCW SpA** and previously known as **LATAMWIN SpA**, hereinafter also referred to interchangeably as the "Company", was incorporated in accordance with the Electronic Registry of Companies and Societies certified by the Ministry of Economy, Development and Tourism by virtue of the provisions contained in Law twenty thousand six hundred and fifty-nine, on the sixteenth day of October of two thousand and fourteen and is included in the registry with the electronic verification code ACxiRamLMT five g. The company thus constituted was migrated to the regular legal regime of joint-stock company, registering its migration extract on page seventy thousand one hundred seventy-two, number thirty-three thousand six hundred thirty-five of the Commercial Registry of the year two thousand twenty of the Real Estate Registrar of Santiago and being published in the Official Gazette on the date of November 2, two thousand twenty. The company was amended by a notarized deed dated January thirteen, two thousand twenty-two, executed at the Notary Public's Office in Santiago, before Mr. Roberto Antonio Cifuentes Allel; the company name was changed from **LATAMWIN SpA** to **INVERSIONES FCW SpA**. Subsequently, the company **INVERSIONES FCW SpA** was reorganized by a public deed dated November ninth, two thousand twenty-two, executed before Ms. Antonieta Rojas Pontigo, Acting Notary of the Forty-Eighth Notary Office of Santiago, and became a limited liability company under the name **INVERSIONES FCW LTD**. Finally, the company was amended by a notarized deed dated the same day, executed at this same notary's office, thereby modifying its management structure. The ID number for **INVERSIONES FCW LTD** is seventy-six million four hundred thirty-five thousand one hundred thirty-four dash seven.

SECOND: The sole partners of the company **INVERSIONES FCW LTD** are: a) **INVERSIONES ALAMEDA SpA**, holding fifty percent of the capital and corporate rights. b) **INVERSIONES DOMINICA SpA** holding fifty percent of the capital and corporate rights.

THIRD: ASSIGNMENTS. ONE) By this instrument, the company **INVERSIONES ALAMEDA SpA**, duly represented as indicated in the appearance, sells, assigns, and transfers to the company **INVERSIONES DOMINICA SpA**—which, as the purchaser, accepts and acquires through its representative—ninety six percent of its shares, equivalent to forty-eight percent of the total capital and corporate rights of the company **INVERSIONES FCW LTD**. The price of the transfer is six hundred ten million pesos, which **INVERSIONES DOMINICA SpA** will pay to the transferor in installments no later than March twenty-four, two thousand twenty-four. TWO) By this instrument, the company **INVERSIONES ALAMEDA SpA**, duly represented as indicated in the appearance, sells, assigns, and transfers to the company **DOMINICA SpA**—which, through its representative, purchases,

accepts, and acquires—two percent of its interest in the company, equivalent to one percent of the total capital and corporate rights of the company **INVERSIONES FCW LTD**. The price of the transfer is three million pesos, which **DOMINICA SpA** shall pay to the transferor in cash, and the transferor hereby acknowledges receipt of this amount in the same form and to its full and complete satisfaction. **THREE)** By this instrument, the company **INVERSIONES ALAMEDA SpA**, duly represented as indicated in the appearance, sells, assigns, and transfers to the company **SIGMA SpA**—which, through its representative, purchases, accepts, and acquires—two percent of its interest in the company, equivalent to one percent of the total capital and corporate rights of the company **INVERSIONES FCW LTD**. The price of the transfer is three million pesos, which **SIGMA SpA** shall pay to the transferor in cash, and the transferor hereby acknowledges receipt of this amount in the same form and to its full and complete satisfaction. **FOUR:** The transferor declares that these rights are transferred “as is,” with all their rights, free from any encumbrance, prohibition, attachment, or any condition that limits their exercise or ownership, and free from litigation. The parties irrevocably waive their right to rescission and expressly state that the transfers described in this instrument have been made with the express consent of the current partners of **INVERSIONES FCW LTD**, who have appeared before this instrument. **FIFTH:** As a result of the transfers of rights described in the preceding Clause Three, the sole members of the company **INVERSIONES FCW LTD** are: one) **INVERSIONES DOMINICA SpA**, holding ninety-eight percent of the capital and corporate rights; two) **SIGMA SpA**, holding one percent of the capital and corporate rights; and three) **DOMINICA SpA**, holding one percent of the capital and corporate rights. **SIXTH:** The bearer of a certified copy of this deed or an extract thereof is hereby authorized to make the required publications and to request and sign the annotations, applications, registrations, and sub-registrations in the relevant registries, and may file any drafts that may be necessary in accordance with the law. **LEGAL REPRESENTATIONS:** The legal representative for **INVERSIONES ALAMEDA SpA** is set forth in a notarized deed dated August twelve, two thousand twenty, executed at the notary office of Mr. Luis Enrique Tavorari Oliveros in Santiago; this deed is not included here as it is known to the parties and the authorizing notary. The legal representative for **INVERSIONES DOMINICA SpA** is set forth in a notarized deed dated August thirty-one, two thousand twenty, executed at the notary office of Mr. Luis Enrique Tavorari Oliveros in Santiago; said deed is not attached here as it is known to the parties and the authorizing notary. The legal representative for **DOMINICA SpA**, is set forth in a notarized deed dated November sixth, two thousand twenty, executed at the notary office of Mr. Luis Enrique

Tavolari Oliveros in Santiago, file number four thousand six hundred sixteen, dash two thousand twenty, which is not included here as it is known to the parties and the authorizing notary. The legal representative for **SIGMA SpA**, is set forth in a notarized deed dated November sixth, two thousand twenty, executed at the notary office of Mr. Luis Enrique Tavolari Oliveros in Santiago, file number four thousand six hundred seventeen, dash two thousand twenty, which is not included here as it is known to the parties and the authorizing notary.
