

ADDENDUM No 1
to the SOFTWARE AND SERVICES LICENSE AGREEMENT
from February 08, 2024
(Hereinafter - "Agreement")

This ADDENDUM No1 to the Agreement is made on March 01,2024 by and between:

HIGHFLIER B.V., a legal entity registered in Curacao under company number 149996, with its registered office at Dr. H. Fergusonweg 1, Curacao (**hereinafter referred to as the "Licensor"**), on the one side; and

POINDER B.V., a legal entity registered in Curacao under company number 166111, with its registered office at Abraham Mendez Chumaceiro Boulevard 03, Curacao, P.O. Box 4750 (**hereinafter referred to as the "Licensee"**), on the other side,

hereinafter jointly referred to as the "**Parties**" and separately – the "**Party**", have concluded the present **ADDENDUM No 1**, for the following:
